

Important CE Update: NYSDA CE Registry is Now CE Navigator

The New York State Dental Association (NYSDA) recently launched CE Navigator, a new recordkeeping platform that allows NYSDA members to submit and track their CE credits more efficiently. **CE Navigator, which is FREE for NYSDA members, replaces the NYSDA CE registry. This means that ALL NYSDA members will now need to create a CE Navigator account to enable NYSDA to upload CE credits from courses taken with Second District Dental Society (SDDS) or any other component dental societies to their CE Navigator accounts.** Additionally, since Sept. 30, 2024, NYSDA has stopped accepting CE certificates via fax, email and mail. If you take courses with providers who are NOT component dental societies, you will need to upload any certificates you receive from them to your CE Navigator account via the CE Navigator website or app for the credits to appear on your transcript.

To create your CE Navigator account, visit nysdentalnavigator.com or download the CE Navigator app via the App Store or Google Play. You will need your license number, license expiration date and your ADA member. To help guide you through the sign-up process, visit bit. ly/CE-Navigator-demo to watch a demo created by NYSDA, which covers everything from setting up your account to adding your CE courses.

FAQs

Will SDDS courses continue to be added to my CE Navigator account?

Yes, SDDS will continue to submit CE rosters to NYSDA for addition to your CE Navigator account.

I have created a CE Navigator account, but I don't see a record of credits from a Second District course I recently took. What should I do?

It can take up to three weeks after a course for credits to show up in your account. If it has been over three weeks and the credits are still missing, it is possible the credits were not uploaded to your account because it was not active at the time NYSDA received the attendance roster. Email info@sddsny.org

Will my current NYSDA registry automatically carry over to CE Navigator?

No, your current NYSDA registry will not transfer over to CE Navigator. However, in the event of an audit or credentialing, contact NYSDA at (800) 255-2100 or ce@ nysdental.org for assistance.

Where can I find my NYSDA transcript?

Your transcript is still available and your CE history will not be lost. To access it, log into the members-only section at nysdental.org. You may also contact NYSDA to request a transcript; however, there is currently a delay in processing requests due to a recent ADA system migration.

The Miracle of the GNYDM

The Greater New York Dental Meeting (GNYDM) is the largest, most successful annual dental meeting in the United States and one of the largest dental congresses globally. Second District Dental Society (SDDS) is extremely fortunate to be one of the two owners of the meeting, along with New York County Dental Society. The Meeting has benefitted SDDS members in many ways through the years by providing world class educational programs and an extraordinary exhibit hall from which members have been able to peruse and try out the most up-to-date materials and equipment available. It is a venue in which to interact with individuals in the forefront of education, research, technique and practice management. In addition, attendees have the opportunity to join with their colleagues in a relaxed, stimulating atmosphere benefitting educationally and even socially, exchanging ideas, experiences and simply catching up.

The true miracle of the Meeting is the fact that since its inception 100 years ago this year, it has been created, supported and maintained by volunteer dentists, not professional meeting planners. The brilliance of the concept, the dedication of the many member volunteer colleagues and the extraordinary evolution and growth of the GNYDM is nothing short of miraculous.

This year's 100th annual session will provide you with a historical journey allowing you to see the meeting evolve from the early days as a local gathering, through the ever expanding venues from the Hotel Pennsylvania to the New York Hilton and finally to today at the Javits Center. A wonderful photographic retrospective will take you through the iterations of the sessions and see the many volunteers who contributed to making the GNYDM what it is today.

As a new dentist in the 1970s, I first volunteered to serve at the Meeting as a subcommittee member. Through subsequent years I continued to volunteer, looking forward to spending time with my colleagues, taking a wide variety of CE both didactic and hands-on, shopping for office

supplies, trying out new materials and techniques and renewing the excitement of actually being a dentist. I always returned to my office renewed and refreshed knowing that all was well in the dental profession.

In the 1990s, after having served as president of the SDDS, I was appointed to the GNYDM Organization Committee (OC), joining the other seven OC members who actually make the Meeting happen. It was an extraordinary, eye-opening experience, which added a new perspective to my understanding of how the Meeting is created. I served four years on the OC, subsequently serving three years as a troubleshooter. In 2002, I began serving a twoyear term as general chairman of the GNYDM, followed by two as an advisory chair. I continue to serve as a member of the Advisory Committee to this day.

Today, as an old, retired practitioner (where has the time gone?!!?) looking back upon the evolution of what was originally a small, local gathering into a global phenomenon admired and respected through the dental profession, I am amazed at the present, latest iteration of the Meeting, which now draws attendees in the tens of thousands from over 130 nations, numbers that couldn't have been imagined 100 years ago.

With the assistance of a small, dedicated and highly skilled staff and the many volunteers dedicating themselves to the annual recreation of the GNYDM phenomenon, the Meeting continues to grow to even greater heights despite wars (World War I, World War II, the Korean War, the Vietnam War, etc.), plagues (the 1918-19 flu and COVID-19 pandemics), economic chaos (the 1929 market crashes and others through the years), terrorist attacks and other challenges. I look forward to watching the continued upward trajectory of the GNYDM with the confidence that the extraordinary volunteers at every level will support and drive the Meeting to even greater unanticipated heights. I have come to understand that:

Introducing the GNYDM General Chairman

It's an honor to be elected as the general chairman of the Greater New York Dental Meeting (GNYDM) and I am excited that we will be celebrating the 100th anniversary of the meeting in 2024.

I think I was born to be a dentist because my father, also a dentist, was my first and still the most influential mentor in my life. To this day, whenever I have an important decision to make, my wife, Susan, will ask me the question "What would your dad do?" I graduated from New York University College of Dentistry in 1986, married Susan two days later and completed a one-year general practice residency (GPR) program at Staten Island University Hospital. I was able to join dad in his practice after my residency and we worked together for 20 years. It was a wonderful experience to practice together and treat all his wonderful patients, sometimes treating three generations in one family in our practice. I particularly enjoyed treating developmentally disabled children and adults at the Terence Cardinal Cooke Health Care Center in Manhattan every Tuesday, also for 20 years. Susan and I have two children: our daughter, Anne Marie, who works for New York City in public health, and our son, John, who works for an investment firm as a medical device analyst.

I attended my first GNYDM as a resident in 1986, when I gave a table clinic about TMJ arthroscopy. I had learned about this treatment by assisting in the operating room with Dr. David Hoffman and Dr. Bernard "Bud" McGivern during my residency. The next year, I gave a lecture about the influence of dentistry on the development of plastic surgery as a specialty during the World War I. Ever since, I have volunteered at the Meeting every year and served on almost all the committees. The Meeting was a great experience for me because I learned how to prep and cement porcelain veneers, place posterior composite restorations, make impressions for and insert implant crowns and complete endodontic treatment with titanium rotary files. All these things I never learned in school despite being a new, young dentist.

In the late 1990s, my dad was appointed to the GNYDM Organization Committee. Through him, I got to know so many wonderful people like the past general chairmen Drs. Anthony Di Mango, James Spencer, Robert Seminara, Howard Lieb and John McIntyre, all from Second District Dental Society (SDDS). Although I am a member of New York County Dental Society (NYCDS), I became friends with the so many of the wonderful people from SDDS. Past General Chairman Dr. John Halikias and I went to Xavier High School and

The GNYDM has had an exciting history over the last 100 years. Its first venue was the Hotel Pennsylvania, followed by the New York Hilton and most recently, the Jacob K. Javits Convention Center. Despite the problems of wars and economic downturns during that time, the Meeting flourished to become the largest dental meeting in the United States and has been a happy and profitable partnership between Second District Dental Society and New York County Dental Society.

GNYDM 100 Year Anniversary

As a past general chairman of the Greater New York Dental Meeting (GNYDM) whose life was dramatically changed after being involved in the GNYDM, I can say with definite certainty that it was phenomenal. My years in organized dentistry were a way that I could give back to the profession I loved, but it was not until I got involved in the GNYDM that I really understood the sense of purpose, family and camaraderie that make up this organization.

In the past, the two dental societies that co-own the GNYDM - Second District Dental Society (SDDS) and New York County Dental Society (NYCDS) - chose the best of their leadership to participate in the GNYDM Organization Committee. Past presi-

dents of SDDS and NYCDS all became involved over the years and were the mainstay of the organization. The two societies allowed the Organization Committee to run independently. This was a good thing, but it has changed. The Organization Committee may be losing some of the independence it had and our Meeting is changing. History will tell if that was the right decision.

Over the years, I had the pleasure of working with three GNYDM executive directors. For the most part they led the Meeting to great heights. We became an international Meeting, an evolution that had its benefits and drawbacks. When I was general chairman of the GNYDM, the 9/11 terrorist attacks occurred. We were the first meeting that came back to the Javits Center after that tragedy. Those were interesting and difficult times, to sav the least.

When I was involved with the GNYDM, the New York Marriot Marquis served as the GNYDM's headquarters hotel. We were partners - so to speak - and our relationship with the hotel staff was beautiful. For a time, the GNDYM was within the Marriott. When they needed the space for themselves, they moved us out, set us up and paid the rent for our new offices. This was unheard of in a normal business sense. That was how we did it.

Over the years, many memorable events have occurred. Two come to mind. The first was when First Lady Barbara Bush was our celebrity speaker. It was interesting to see how the Secret Service took over protecting her. It was also interesting that those on the stage with her had obviously been vetted by the secret service. The second event was our weekly Nathan's Hall afternoon break. At selective times the entire GNYDM Organization Committee and staff, except for essential

individuals, would gather for a short break at Nathan's to enjoy hot dogs and fries. The camaraderie and team building were incredible, truly making this meeting unique.

In my years involved in the Meeting, I truly learned meeting planning. Those lessons served me well and I soon became executive director of the Northeastern Society of Periodontists, a position in which I served for 32 years until I retired. The GNYDM was the source of all my meeting planning experience.

To say my years at the GNYDM were the most satisfying time of my professional career is putting it mildly. Dentistry has always been good to me, but my time at the GNYDM was truly special. I only wish that those involved actively with the Meeting come away with the same feeling that I have about this gem of a meeting. I wish all good things for the next 100 years of the GNYDM's existence.

History of the GNYDM Retold

As generations pass, the history of our dental accomplishments slowly dissipates like long forgotten dreams. Seeded within a few published historical records that were written well after the events described herein, we travel back in time 100 years ago to December 1924. At that time, Dr. James Foster Hasbrouck, the president of the First District Dental Society (FDDS), now called New York County Dental Society (NYCDS), was working in conjunction with Dr. Armin Wald (FDDS president of 1928-1929) and immediate past presidents Dr. John L. Peters (1923-1924) and Dr. Alfred Walker (1922-1923). They decided it was time to start a continuing education program for dentists. This idea was originally expressed at the Bronx County Dental Society, which was part of the FDDS at the time, at one of their meetings five years before.1

Dr. Armin Wald was appointed chairman of the FDDS Executive Committee, which consisted of eight men. They worked together and produced the first meeting, which was called the "**Better Dentistry**" Meeting. For the first five years of the Meeting, it was run by the Executive Committee and its chairman. The executive chairman (Table 1) was the precursor of the Greater New York Dental Meeting (GNYDM) general chairman (Table 2).

The location of the first Meeting is controversial and may have been at the Commodore Hotel, Hotel Pennsylvania, or even the New York Academy of Medicine. In the GNYDM 1949 program guide celebrating the 25th year anniversary of the meeting, Dr. K. Neil Donally wrote how the first Meeting occurred in the "old Academy of Medicine building on West 43rd Street and the demonstrations were given at various colleges and in some of the hospitals." We do know

that 250 dentists registered for the 1924 Meeting and they gave overwhelmingly positive five-star ratings on their experience. The following year, 1925, the Meeting was held at the Hotel Pennsylvania, which was the largest hotel in New York City at the time. Only members of the American Dental Association were allowed to attend. Exhibit space was not sold because they did not want to be seen as interfering (and causing any bad feelings) with the New York State Dental Society's annual meeting in May. To defray costs, a \$5 admission fee was charged.² The Meeting ran for three days from Wednesday, Dec. 2 to Friday, Dec. 4. There was also a Thursday evening formal dinner that concluded with dancing late into the night.³ By 1927, the Meeting began allowing exhibitors; however, the \$5 registration fee continued. There is some discrepancy on what year manufacturers were allowed to exhibit. Some believe it started in 1926; however, the 1926 publication Dental Cosmos has a blurb from Dr. Waldo Mork, who wrote that there would be no Manufacturer's exhibit that year.⁴ In 1928, the meeting went from three days to four days.⁵

During the first five years of the Meeting, registration exploded.

There was such a tremendous increase that the FDDS needed help to handle the expansion and called upon their Second District Dental Society (SDDS) colleagues. Dr. Charles M. McNeely, who was president of the SDDS in 1929 and later of the Dental Society of the State of New York (now the New York State Dental Association) in 1935, helped persuade the SDDS Board to join the FDDS as co-promoters of the meeting. It was felt that the SDDS could further increase the scale and participation. And so, in 1929, the meeting's name changed again to the "December Meeting for Better Dentistry" 6 and went from a fourday meeting to a five-day meeting. That same year, they formed the Organization Committee and elected their first general chairman, Dr. John T. Hanks. The meeting was open to all SDDS and FDDS members without a fee.

It seemed every year the meeting's name changed. In 1930, the meeting was billed as "**The Greater New York December Meeting for Better Dentistry**" ⁷ A year later in 1931, the Meeting was billed as "**The Greater New York December Meeting**" ⁸In 1937, the final name change occurred and the Meeting was called and continues to be known as **The Greater New York Dental Meeting.** The first rules and regulations of the Meeting were also promulgated this same year.

Though where exactly the first Meeting took place is debatable, we do know that from 1925 to 1948 it was housed in the Pennsylvania Hotel and continued there even as the hotel was sold a few times and underwent name changes and renovations. Its new name became Hotel Pennsylvania – The Statler Hotel in New York, which was originally built by the Pennsylvania railroad and the majority share of the lease was later acquired by Ellsworth M. Statler.

Pennsylvania Hotel property was bought by the Statler Hotel chain in 1948 and became the Hotel Statler In 1949. Conrad Hilton acquired the Hotel Statler in 1954 and renamed it the Statler Hilton in 1958.9 Here, the GNYDM continued its exponential growth until it was bursting at the seams and moved to the New York Hilton Hotel in 1973. 10 When the New York Hilton opened for business in 1963, it overshadowed the Hotel Pennsylvania, becoming the largest hotel in New York City. Registration continued to rise and the GNYDM further evolved, leading to another venue change in 1987

and landing at the Jacob K. Javits Convention Center, the largest convention center in New York City, where it still resides.

Besides the amazing GNYDM volunteers, a meeting the size of the GNYDM must employ full and part-time loyal, hard-working and creative staff year-round to help conduct operations. The Meeting office staff was initially led (Table 3) by Mrs. Edith Davies as general secretary and then Mrs. Mabel Purdy as executive secretary. After almost 35 years of service, Mrs. Purdy retired and Helen M. Harrison took over as executive secretary. In 1974, Dr. Irving Gruber became the meetings first executive director, followed by Dr. Howard Menell and then Dr. Robert Edwab. Today the GNYDM has its own office and a staff of seven, led by Tom Loughran, who serves as the GNYDM general manager.

A century has passed and the GNYDM continues to flourish. In 1924, 250 eager dentists convened together to participate in postgraduate education. At the spectacular 2023 GNYDM, 36,081 attendees navigated the massive Javits Center meeting space, with 508 exhibitors displaying their products in 990 booths. This year's 2024 GNYDM can only be better and will have over 250 education programs spanning six days. Thanks to the years of tenacity, diligence and determination of our volunteers and staff, as well as the GNYDM Organization Committee, Advisory Committee and general chairman, the GNYDM continues to dominate dental meetings. It remains the largest dental meeting in the country and is optimally positioned for another 100 years of greatness.





Celebrating a Century of Excellence: The Greater New York Dental Meeting

As we mark the centennial celebration of the Greater New York Dental Meeting (GNYDM), it's a fitting moment to reflect on the remarkable journey that has brought us to where we stand today – as the largest dental convention and event in the United States.

The GNYDM story began humbly in the 1920s with just a few hundred attendees and a couple of educational programs. It was the collective efforts of a group of dentists from Brooklyn, Staten Island and Manhattan that laid the foundation for what would become an iconic event in the field of dentistry.



In 1987, the GNYDM signed papers with the Jacob K. Javits Convention Center, marking a fresh beginning with new prospects. Today, we remain the U.S. dental industry leader in international trade and commerce.

The GNYDM exhibit floor offers special discounts and giveaways, with dental professionals visiting over 1,020 exhibit booths.

But it's not just about the numbers – it's about the quality of education and experiences we provide. With over 265 seminars and hands-on workshops, including programs in Spanish, Portuguese, Russian and Chinese, we strive to meet the diverse needs of our attendees. Additionally, our meetings for specialists cover a wide range of topics, from implant dentistry and orthodontics to pediatric dentistry, sleep apnea and oral cancer.

As we look back on a century of excellence, we are grateful for the support of our attendees, exhibitors, and partners who have helped us reach this milestone. Here's to another century of advancing oral health and transforming lives through the Greater New York Dental Meeting!

Update for Medication-Related Osteonecrosis of the Jaw

Featured Clinician: KENNETH E. FLEISHER, D.D.S., F.A.C.S.

Clinical Professor, Department of Oral and Maxillofacial Surgery, New York University College of Dentistry

Bone health and maintenance of bone integrity are important concerns during comprehensive cancer care and management of osteoporosis. Bisphosphonates and denosumab are antiresorptive medications widely used for the prevention and treatment of osteoporosis and skeletal complications associated with metastatic cancer and multiple myeloma. Medication-related osteonecrosis of the jaw (MRONJ) related to antiresorptive therapy is a condition that has created numerous dilemmas in patient management and may have a broad health impact. Minimizing the risk of MRONJ is critical, not only to prevent MRONJ but also to maximize the benefit of antiresorptive therapy. This case-based presentation will review evidence-based data that has led to paradigm shifts for pathogenesis and innovative strategies for risk assessment, prevention and management of MRONJ.
